IN THE SUPERIOR COURT OF GUAM DECLARATION

I, RICHELLE Y. CANTO, a duly appointed Assistant Attorney General, aver upon information and belief that the following declaration is true. I have reviewed Guam Police Department (GPD) Reports # 21-19719 submitted by Officer J. Aguon (#4113), which revealed the following occurred in Guam:

On or about August 15, 2021, at approximately 11:08 p.m., GPD officers responded to a person in need of assistance at a 76 gas station in Tamuning, Guam. Officers met with Terry Gathranz (victim), who was hiding inside the gas station bathroom. Terry reported she ran to the gas station to call the police because her boyfriend FRANCIS FILERUW (defendant) had threatened to kill her and her family earlier that night.

Gathranz indicated that earlier that night she and **FILERUW** were arguing about changing the names of their children. She stated her two-year-old infant son was crying, and **FILERUW** slapped the infant on the face, placed him outside their residence, and told Gathranz not to touch him or he would kill her. Gathranz reported **FILERUW** stated he would "shoot me to death soon" and he was "going to kill any of her family." Gathranz told officers she was so afraid of **FILERUW** that she ran to the gas station, called the police, and hid out in the bathroom.

Gathranz reported she has been in a relationship with FILERUW for approximately six (6) years and they have two (2) children together, but she "only sometimes" resides with FILERUW because of "how aggressive FILERUW can be." Officers noted no visible injuries or marks on the infant. FILERUW denied striking the infant or making threats to Gathranz.

FILERUW is on pretrial release in CF0416-19, where he was ordered by the Magistrate Judge on July 21, 2019 not to commit any acts of family violence against, and not to harass, annoy, or molest any family or household members.

Based on the foregoing, there is probable cause to charge **FRANCIS FILERUW** with the following:

- One (1) count of TERRORIZING (as a Third Degree Felony), in violation of Title 9 G.C.A. §19.60(a) and (b) - Terry Gathranz, with special allogation Felony Committed on Felony Release in violation of 9 Title 9 G.C.A. §80.37.1;
- 2. One (1) count of **FAMILY VIOLENCE** (as a Misdemeanor), in violation of Title 9 G.C.A. §§30.10(a)(2) and (b) and 30.20(a) *Terry Gathranz*;
- 3. One (1) count of CHILD ABUSE (as a Misdemeanor), in violation of Title 9 G.C.A. \$31.30(a)(2)(C) and (b) - male infant Gathranz (2 years old); and
- 4. Two (2) count of VIOLATION OF A COURT ORDER (as a Misdemeanor), in violation of Title 9 G.C.A. §30.40(a)(1) Terry Gathranz and male infant.

I declare under penalty of perjury that the foregoing is true and correct. Executed this 16th day of August, 2021.
