IN THE SUPERIOR COURT OF GUAM DECLARATION

I, CHRISTINE SANTOS TENORIO, a duly appointed Assistant Attorney General, aver upon information and belief that the following declaration is true. I have reviewed Guam Police Report 21-23748 submitted by P.O. Pangelinan and others, which revealed the following occurred in Guam:

On or about September 29, 2021, at approximately 5:50 p.m., officers of the Guam Police Department responded to an assault complaint at a Yigo residence. Upon arrival, officers met with JOHN ("JOUAN"), who indicated this his son, MATHEW JOHN ("DEFENDANT") had assaulted his two other sons, and

At approximately 3:00 p.m. that afternoon, JOUAN heard DEFENDANT, and yelling at each other in the living room. JOUAN then observed DEFENDANT use a baseball bat to hit both and on the head. and lost consciousness momentarily.

DEFENDANT then used the bat to hit in the leg, causing to regain consciousness. attempted to block more blows from the baseball bat with his hand, and the bat hit in the wrist. DEFENDANT then used the baseball bat to hit in the rib cage.

Next, DEFENDANT retrieved a machete and swung the machete at tried to block the machete and was cut by the machete blade. The yelled at DEFENDANT to stop, but DEFENDANT continued to swing the machete at hitting him in the back and arm. JOUAN observed lose consciousness, and JOUAN called 911.

DEFENDANT then went into the bedroom and assaulted his girlfriend, chest and face while was holding their four-month-old baby, M.R. DEFENDANT then punched his baby, M.R., in the head. Officers observed a laceration and swelling to seve and redness on M.R.'s head. Medics treated and M.R. at the scene.

Police observed that had swelling and redness to his ribcage, a laceration to his hand, head, and back, and redness and swelling to his right face. told police he was in a lot of pain, and had a hard time breathing. Police observed that redness and swelling to his right wrist, swelling to his right thigh, and a laceration to his right hand. indicated that he was in pain. Both and were transported to the hospital by medics.

Officers interviewed DEFENDANT, who stated that "he hit them with a baseball bat and that they are all 'fake' and they all deserved it." Police confiscated an aluminum baseball bat from the scene.

DEFENDANT is on pre-trial release for Possession of a Schedule II Controlled Substance as a Third Degree Felony in CF329-21 and is also on pre-trial release in CF450-

19 for three counts of Criminal Mischief as a Third Degree Felony. As part of his pre-trial release conditions, DEFENDANT was ordered not to use alcohol or drugs and to obey all laws. DEFENDANT was released on August 9, 2021.

DEFENDANT is also on probation in CF162-19 for Aggravated Assault as a Third Degree Felony and in CM166-20 for Family Violence as a Misdemeanor against As apart of his probation conditions, DEFENDANT was ordered not to harass, physically strike, injure, or commit acts of family violence against The Defendant entered this global plea agreement on August 9, 2021.

Based on the foregoing, there is probable cause to charge MATHEW JOHN with:

- 1. 3 counts of FAMILY VIOLENCE (as a Third Degree Felony), in violation of 9 GCA § 30.10(a)(1) and 9 G.C.A. § 30.20(a) with SPECIAL ALLEGATION OF POSSESSION OR USE OF A DEADLY WEAPON, in violation of 9 GCA § 80.37 and NOTICE: FELONY ON FELONY RELEASE, in violation of 9 GCA § 80.37.1;
- 2. 3 counts of AGGRAVATED ASSAULT (as a Third Degree Felony), in violation of 9 GCA § 19.20(a)(3);
 - a. Bodily injury to with a baseball bat

 - b. Bodily injury to with a machetec. Bodily injury to with a baseball bat
- 3. 2 counts of FAMILY VIOLENCE (as a Misdemeanor) against M.R., in violation of 9 G.C.A. \S 30.10(a)(1);
- 4. VIOLATION OF A COURT ORDER (as a Misdemeanor) against I in violation of 9 G.C.A. § 30.40(a)(1).

I declare under penalty of perjury that the foregoing is true and correct. Executed on this 30th day of September, 2021.
