CHARGE TWO

On or about September 14, 2021, in Guam, JESSE JAMES FEJERANG (aka Jesse Fejeran Fejerang) did commit the offense of Family Violence (As a 3rd Degree Felony), in that he did recklessly cause or attempt to cause bodily injury to another family member or household member, that is, Y.K.L.G. (DOB: 04/13/2009) in violation of 9 GCA §§ 30.10(a)(1) and 30.20(a).

CHARGE THREE

On or about September 14, 2021, in Guam, JESSE JAMES FEJERANG (aka Jesse Fejeran Fejerang) did commit the offense of *Violation of Court Order* (as a Misdemeanor), in that he knowingly violated a court order filed on April 5, 2019, in the Superior Court of Guam Criminal Case No. *CM0144-19*, enjoining the Defendant from committing acts of violence against, or from harassing, annoying, or molesting the victim or other family household members, in violation of 9 GCA § 30.40(a)(1).

IN THE SUPERIOR COURT OF GUAM DECLARATION

I, RICHELLE Y. CANTO, a duly appointed Assistant Attorney General, aver upon information and belief that the following declaration is true. I have reviewed Guam Police Department (GPD) Reports # 19-22921 and 21-22368 submitted by Officers D.T. Pangelinan (#728), and J.S. Ascura (#647), which revealed the following occurred in Guam:

On or about September 14, 2021, at approximately 9:00 p.m., GPD officers responded to a physical disturbance at a residence in Yigo, Guam. Officers met with Tatianijean Leon Guerrero (complainant) who reported her brother JESSE JAMES FEJERANG (defendant) had become angry and "choked" their minor sister Y.K.L.G. (DOB: 04/13/2009, 12 years old) (victim). Y.K.L.G. indicated she had turned on the light in the outdoor kitchen because she was going to eat at the table. The table was located immediately beside FEJERANG's military style cot, where FEJERANG was asleep. Y.K.L.G. told officers she went back inside the house momentarily to use the restroom but FEJERANG woke up, became angry, and pushed her on her right shoulder causing her to fall. When Y.K.L.G. stood back up, FEJERANG placed both his hands on her neck, grabbed her neck, and applied pressure, causing her to have difficulty breathing. Tatianijean reported she saw FEJERANG "choking" their younger sister and yelled at him to stop, and that she "could tell by [Y.K.L.G.'s] facial expression that she was hurting."

Officers were unable to locate **FEJERANG** on that day. **FEJERANG** was also wanted for questioning regarding an incident that occurred on August 10, 2019, where **FEJERANG** was reported to have slapped on the face and pushed to the ground another minor sister, **B.L.G.** (11 years old at the time).

On October 8, 2021, police located **FEJERANG** and interviewed him in connection with both 2019 and 2021 incidents. **FEJERANG** told officers he had been arrested for an incident involving yet another sister whom he identified as "and admitted he had pushed B.L.G. in 2019. **FEJERANG** told officers that he was trying to teach his sisters "about life."

FEJERANG is on pretrial release in CM0144-19, where he is charged with Assault and Family Violence against another sister, who was 40 weeks pregnant at the time. In CM0144-19, FEJERANG was ordered by the Honorable Benjamin C. Sison, Jr. on April 5, 2019 to refrain from committing acts of violence against, or from harassing, annoying, or molesting the victim or other family household members.

Based on the foregoing, there is probable cause to charge **JESSE JAMES FEJERANG** with the following:

- 1. One (1) count of **STRANGULATION** (as a Third Degree Felony), in violation of Title 9 G.C.A. §19.80(a) and (b) as to victim Y.K.L.G. (DOB: 04/13/2009);
- 2. One (1) count of **FAMILY VIOLENCE** (as a Third Degree Felony), in violation of Title 9 G.C.A. §30.10(a)(1) and 30.20(a)(2) as to victim Y.K.L.G. (DOB: 04/13/2009); and
- 3. One (1) count of **VIOLATION OF A COURT ORDER** (as a Misdemeanor), in violation of Title 9 G.C.A. §30.40(a)(1) as to victim Y.K.L.G. (DQB: 04/13/2009).

I declare under penalty of perjury that the foregoing is true and correct. Executed this 9th day of October, 2021.
