

**MAGISTRATE'S COMPLAINT**

The Attorney General of Guam hereby accuses **JOHN MIKE MULIAGA** and **FIATAUGALUIA AHKEE (aka Fiataugaluia Ah Kee)** of certain crimes committed as follows:

**FIRST CHARGE**

On or about the 9<sup>th</sup> day of October, 2021, in Guam, **JOHN MIKE MULIAGA** did commit the offense of *Aggravated Assault (As a Second Degree Felony)*, in that he did recklessly cause or attempt to cause serious bodily injury to another, *that is: Jaron Weilbacher*, in circumstances manifesting extreme indifference to the value of human life, in violation of 9 GCA § 19.20(a)(1).

1 **SECOND CHARGE**

2 **Count One**

3 On or about the 9<sup>th</sup> day of October, 2021, in Guam, **JOHN MIKE MULIAGA** did commit  
4 the offense of *Assault (As a Misdemeanor)*, in that he did recklessly cause or attempt to cause bodily  
5 injury to another, *that is: Jaron Weilbacher*, in violation of 9 GCA § 19.30(a)(1).


13 On or about the 9<sup>th</sup> day of October, 2021, in Guam, **JOHN MIKE MULIAGA** did commit

19 **Fiataugalua Ah Kee**) did commit the offense of *Assault (As a Misdemeanor)*, in that he did  
20 recklessly cause or attempt to cause bodily injury to another, *that is: Jaron Weilbacher*, in violation  
21 of 9 GCA § 19.30(a)(1).

## IN THE SUPERIOR COURT OF GUAM

### DECLARATION

COMES NOW, SEAN BROWN, a duly appointed Assistant Attorney General, and aver, upon information and belief, that the following is true.

I have reviewed Guam Police Report No. 21-24704 submitted by GPD Officer C.D. Champion and others which sets forth that the following events occurred on Guam.

On or about October 9, 2021, police responded to a disturbance at King's Restaurant in Tamuning. Police arrived and noted a male later identified as Jaron Weilbacher on the ground who was unresponsive and unconscious. Police reported that Jaron was brought to Guam Memorial Hospital where he was pronounced dead. Witnesses described blood on Jaron's face and droplets of blood around him.

Police spoke with a security guard via multiples interactions who explained that Jaron was with two other males identified as Selerino Henry and Elijah Tierra. The security guard informed police that another group which included several people including two males later identified as JOHN MULIAGA (Defendant Muliaga) and FIATAUGALUIA AHKEE (Defendant Ahkee) was present at location. The security guard stated that Defendant Muliaga had a red hat, black pants and a long beard or goatee while Defendant Ahkee was wearing white pants. The security guard told police that Jaron or Selerino, he did not know who, put his hands up with palms facing out while approaching Defendant Muliaga when Defendant Muliaga punched the male, who had his hands up, in the face with a closed fist where the male then fell to the ground. The security guard gave an earlier statement indicating that Defendant Muliaga struck Jaron, Selerino and Elijah at different times during the altercation. The security guard stated that Defendant Muliaga struck Jaron several times after Jaron fell to the ground.

The security guard observed Elijah attempting to assist one of the males who was now sitting up on the ground when Defendant Muliaga struck Elijah on the face with a closed fist. The security guard then observed Defendant Muliaga strike the male being assisted in the face again with a closed fist followed by an open palm. The security guard told police that Defendant Ahkee then struck the other male who was unconscious on the floor with a closed right fist. Other witness oral statements and video evidence make it appear that the unconscious male was Jaron.

Other witnesses described that a verbal altercation occurred between the different males prior to the assaults.

Video footage appears to depict Defendant Muliaga striking Jaron at least once in the facial area while Jaron appears to be unconscious and lying on his back on top of what appears to be a concrete floor.

Based on the forgoing, there is probable cause to charge JOHN MULIAGA with one count of AGGRAVATED ASSAULT (as a Second Degree Felony) in violation of Title 9 G.C.A. § 19.20(a)(1); and with three counts of ASSAULT (as a Misdemeanor) in violation of Title 9 G.C.A. § 19.30(a)(1).

Based on the forgoing, there is probable cause to charge FIATAUGALUIA AHKEE with one count of ASSAULT (as a Misdemeanor) in violation of Title 9 G.C.A. § 19.30(a)(1).

I declare under penalty of perjury that the foregoing is true and correct.
