

**MAGISTRATE'S COMPLAINT**

The Attorney General of Guam hereby accuses **YOSHIRO RUBEN (aka Isoi Ruben)** of certain crimes committed as follows:

**FIRST CHARGE**

On or about the 10<sup>th</sup> day of October, 2021, in Guam, **YOSHIRO RUBEN (aka Isoi Ruben)** did commit the offense of *Aggravated Assault (As a 2<sup>nd</sup> Degree Felony)*, in that he did recklessly cause or attempt to cause serious bodily injury to another, *that is: Shawn Kikku*, in circumstances manifesting extreme indifference to the value of human life, in violation of 9 GCA § 19.20(a)(1) and (b).

**SPECIAL ALLEGATION:**  
***Possession or Use of a Deadly Weapon***

On or about the 10<sup>th</sup> day of October, 2021, in Guam, **YOSHIRO RUBEN** (*aka Isoi Ruben*) did knowingly and unlawfully possess or use a deadly weapon, *that is: a machete*, in the commission of a felony, *that is: Aggravated Assault (As a 2<sup>nd</sup> Degree Felony)*, in violation of 9 GCA § 80.37.

**SECOND CHARGE**

**Count One**


On or about the 19<sup>th</sup> day of October, 2021, in Guam, **YOSHIRO RUBEN** (*aka Isoi Ruben*) did commit the offense of *Criminal Mischief (As a 3<sup>rd</sup> Degree Felony)*, in that he did intentionally damage the motor vehicle of another, *to wit: a 2004 Toyota Corolla*, belonging to *Paul Eliou*, in violation of 9 GCA §§ 34.50(d) and 34.60(a), as amended.

**Count Two**

On or about the 19<sup>th</sup> day of October, 2021, in Guam, **YOSHIRO RUBEN** (*aka Isoi Ruben*) did commit the offense of *Criminal Mischief (As a 3<sup>rd</sup> Degree Felony)*, in that he did intentionally damage the motor vehicle of another, *to wit: a 2001 Nissan Pathfinder*, belonging to *Paul Eliou*, in violation of 9 GCA §§ 34.50(d) and 34.60(a), as amended.

**DECLARATION**

I, STEVEN J. HADERLIE, Assistant Attorney General, aver upon information and belief that this declaration is true. I have reviewed Guam Police Report No. 21-24884 and 21-25754, submitted by GPD Officer J. Young and others. The reports state that these events occurred on Guam:

On or about October 10, 2021 at about 10:33 p.m. police spoke with Shawn Kikku (victim 1) at a Dededo residence. Kikku said he and his cousin YOSHIRO RUBEN aka ISOI RUBEN (defendant) had been drinking, and then RUBEN attacked Kikku with a machete. RUBEN swung the machete toward Kikku's head, and Kikku blocked the machete with his hands. Police saw that both Kikku's hands had serious lacerations approximately four inches long that exposed flesh and bone and were bleeding profusely. Kikku also had bruising and swelling to his right ear. Kikku drifted in and out of consciousness as he spoke with police.

Nine days later, on or about October 19, 2021 at about 6:00 p.m., police went to the same Dededo residence and spoke with Paul Eliou (victim 2) who said RUBEN had damaged two of his vehicles. Eliou said he saw RUBEN in the street highly intoxicated and yelling. RUBEN struck Eliou's Nissan Pathfinder with a piece of wood. Then RUBEN threw a cement block through the rear window of Eliou's Toyota Corolla. Police saw that the Pathfinder had a dent above the left tail lights. The Corolla's rear window was shattered. Police saw a cement block on the Corolla's rear seat floor area.

Police asked Eliou about Kikku's wellbeing since it appeared Eliou and Kikku reside at the same residence. Eliou then told police he was a witness to the machete incident. He said he watched as RUBEN struck Kikku with the machete. He said he hid in his residence out of fear RUBEN would attack him. He saw police handling it, so he didn't report it.

Police then arrested RUBEN and advised him of his rights. Later, RUBEN told police Kikku took stuff from RUBEN's house, and, in RUBEN's words, "That's why I hurt him."

Based on the foregoing, there is probable cause to charge YOSHIRO RUBEN aka ISOI RUBEN with the following:

- One count of AGGRAVATED ASSAULT (As a 2<sup>nd</sup> Degree Felony), against Shawn Kikku, in violation of 9 GCA § 19.20(a)(1) and (b);
  - With a Special Allegation of Possession or Use of a Deadly Weapon, in violation of 9 GCA § 80.37; and
- Two counts of CRIMINAL MISCHIEF (As a 3<sup>rd</sup> Degree Felony) in violation of 9 GCA §§ 34.50(d) and 34.60(a).
