MAGISTRATE'S COMPLAINT

The Attorney General of Guam hereby accuses **JOLEEN-LEE MEIPEL RANKIN** of certain crimes committed as follows:

CHARGE ONE

*Count One*

On or about the period between November 3, 2018 and January 23, 2019, inclusive, in Guam, **JOLEEN-LEE MEIPEL RANKIN** did commit the offense of *Dissemination of Child Pornography (As a 1<sup>st</sup> Degree Felony)*, in that she did, knowing or having reason to know its character and content, knowingly disseminate electronically store data or any other material that

1 contains an image of child pornography, to wit: a pornographic visual presentation involving the use  
2 of a minor engaging in sexual conduct, specifically, sexual penetration between males and a minor,  
3 that is *S.K. (DOB: 05/29/2002)*, in violation of 9 GCA 25A302(a)(1) and (c).

4 *Count Two*

5 On or about the period between November 3, 2018 and January 23, 2019, inclusive, *but at a*  
6 *time different from Charge One, Count One*, in Guam, **JOLEEN-LEE MEIPEL RANKIN** did  
7 commit the offense of *Dissemination of Child Pornography (As a 1<sup>st</sup> Degree Felony)*, in that she  
8 did, knowing or having reason to know its character and content, knowingly disseminate  
9 electronically store data or any other material that contains an image of child pornography, to wit: a  
10 pornographic visual presentation involving the use of a minor engaging in sexual conduct,  
11 specifically, sexual penetration between males and a minor, that is *S.K. (DOB: 05/29/2002)*, in  
12 violation of 9 GCA 25A302(a)(1) and (c).

13 *Count Three*

14 On or about the period between November 3, 2018 and January 23, 2019, inclusive, *but at a*  
15 *time different from Charge One, Counts One and Two*, in Guam, **JOLEEN-LEE MEIPEL**  
16 **RANKIN** did commit the offense of *Dissemination of Child Pornography (As a 1<sup>st</sup> Degree*  
17 *Felony)*, in that she did, knowing or having reason to know its character and content, knowingly  
18 disseminate electronically store data or any other material that contains an image of child  
19 pornography, to wit: a pornographic visual presentation involving the use of a minor engaging in  
20 sexual conduct, specifically, sexual penetration between males and a minor, that is *S.K. (DOB:*  
21 *05/29/2002)*, in violation of 9 GCA 25A302(a)(1) and (c).

22 *Count Four*

23 On or about the period between November 3, 2018 and January 23, 2019, inclusive, *but at a*  
24 *time different from Charge One, Counts One, Two and Three*, in Guam, **JOLEEN-LEE MEIPEL**  
25 **RANKIN** did commit the offense of *Dissemination of Child Pornography (As a 1<sup>st</sup> Degree*  
26 *Felony)*, in that she did, knowing or having reason to know its character and content, knowingly  
27 disseminate electronically store data or any other material that contains an image of child  
28 pornography, to wit: a pornographic visual presentation involving the use of a minor engaging in  
sexual conduct, specifically, sexual penetration between males and a minor, that is *S.K. (DOB:*  
*05/29/2002)*, in violation of 9 GCA 25A302(a)(1) and (c).



CHARGE TWO

On or about the period between November 3, 2018 and January 23, 2019, inclusive, in Guam, **JOLEEN-LEE MEIPEL RANKIN** did commit the offense of *Possession of Child Pornography (As a 2<sup>nd</sup> Degree Felony)*, in that knowing or having reason to know its character and content, she did possess any electronically stored data or any other material that contains an image of child pornography, in violation of 9 GCA 25A202(a)(1) and (c).

DECLARATION

COMES NOW Charles Kinnunen, a duly appointed Assistant Attorney General, and aver, upon information and belief, that the following is true. I have reviewed Guam Police Department Report number 19-0207 submitted by PO Raval (200) and others. The report revealed the following:

On or about a period between November 3, 2018 and January 23, 20019, on Guam, a sexually explicit video of a female minor engaging in acts of sexual contact and sexual penetration with males was seen on FaceBook Messenger on a FaceBook post. The minor was identified as S.K. (DOB 5/29/2002). The minor was located and admitted that she was, in fact the female seen in the explicit video, and that the incident occurred on Guam, November 3 or 4, 2018. Through investigation, **JOLEEN -LEE M. RANKIN** was interviewed and admitted that she obtained a cell phone that belonged to a person she knew with the pornographic visual representation of the minor S.K (DOB 5/29/20002) engaging in sexual conduct and sent the video to herself through her Facebook Messenger and this occurred a few days after Christmas 2018. A week later **JOLEEN-LEE M. RANKIN** visited a friend and showed her the video and sent it to that friend through Face Book Messenger, to include three other individuals. **JOLEEN-LEE M. RANKIN** said she knew it was wrong what she did.

Based on the foregoing, there is probable cause to charge **JOLEEN-LEE M. RANKIN** with four counts of **DISSEMINATION OF CHILD PORNOGRAPHY (As a First Degree Felony)**, in violation of 9 GCA 25A203(a)(1) and (c); and one count of **POSSESSION OF CHILD PORNOGRAPHY (As a Second Degree Felony)**, in violation of 9 GCA 25A202(a)(1) and (c).

I declare under penalty of perjury that the foregoing is true and correct. Executed on February 9, 2019.
